


# Admissions – Timmons' World Referral Reminder

## Giving - Laying the Smack Down on DePauw

For the last several years, Wabash and DePauw have had a friendly competition for alumni participation in annual giving. It is not a competition over amounts of money, but over percentage of alumni who participate. Last year we tied. This year is again close, but I'm sure we can come out on top – statistically, we should be spanking them because our donor pool is smaller and our percentages can easily jump multiple points with one or two additional people. Please take this opportunity to tell DePauw that they are still second best. Our fiscal year ends at the end of June, so please get on the Wabash website and make your contribution by the end of June.



**So why is giving percentage important anyway?** Wabash is not just a college, it is also a business. When we solicit funds from endowments, grants, etc., they look at our academic profile and all as well as our investor base. If we have solid participation in alumni giving, co-contributors (like the Lilly Endowment) see Wabash as a good risk for their money and are more likely to award grants. I never really thought about Wabash as a business until I talked with Chip about it during our Big Bash a few years ago, but it makes sense.

What are my options? I put a credit card on file and have a nominal amount deducted monthly over the course of a year. What happens is that I end up increasing my overall giving for the year (and my tax credit) by about 4-fold, but my monthly contributions cost me as much as one lunch out. If you don't want the hassle of a one time gift and feel like the financial pressure of that one time gift is just too much, you might give it a look.
